1. WHAT IS THIS JUMPER ABOUT?

This is an Islamic term financing facility to assist PUNB's JumPER program graduates to start up or expand their business.

2. WHO CAN APPLY?






- Graduates who completed JumPER PUNB program and obtained valid support letter from the JumPER mentor.
- 100% Bumiputera owned.
- Date of application must be within three (3) years from the completion date of JumPER PUNB program.
- Updated financial record.
- Shariah compliance business.
- Good credit record and any other financial institutions.
- Fulfill documentation requirement upon application and disbursement of financing.



3. WHAT IS THE SHARIAH CONTRACT APPLICABLE?

The applicable Shariah contract is Tawarruq where based on Wa'd from the customer, PUNB will purchase commodity from a commodity trader and then sells the commodity to the customer based on Murabahah sales price (cost of commodities with profit) on deferred payment basis and as the customer's agent, PUNB sells the commodity to third party buyer at cash. The cash collected from third party buyer will be deposited into customer's special designated account. Currently the commodities being used are Crude Palm Oil (CPO).

4. WHAT DO I GET FROM THIS PRODUCT?

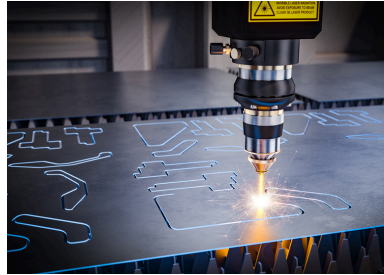

8. WHAT IF I FAIL TO FULFILL MY OBLIGATIONS?

If you begin to experience difficulties in meeting your monthly instalments, you are advised to contact PUNB through your designated monitoring officer or customer service centre immediately, so that we may assist/propose on viable recommendation as early as possible. This will prevent you from experiencing difficulties in the event that you fail to fulfill your obligations.



9. WHAT IF I FULLY SETTLE THE FINANCING BEFORE ITS MATURITY?

You will need to pay the total outstanding balance and any amount due and payable to PUNB i.e. instalment arrears, late payment charge (if any). There is no fee for the early settlement.

PUNB may grant Ibra' at its absolute discretion whenever and whichever way applicable. Ibra' may be granted on the unearned profit portion of the Facility in the following situations:

- a) Upon early full settlement of the Facility; and/or
- b) Upon partial utilization of the Facility, on the unutilized amount.

10. DO I NEED A GUARANTOR?

We require personal guarantee for the financing.

We also require this financing to be secured by a third-party guarantee by a Malaysian citizen with 3% monthly income of total financing applied or any proof of saving at any financial institution.

11. DO I NEED ANY TAKAFUL COVERAGE?

Yes, Takaful plan is mandatory for JumPER.

Reducing Term Takaful (RTT) covers death or total and permanent disability. In the event of such an incident, the coverage will help you in paying your financing.

A Business Premise Takaful is also mandatory. Business premise takaful covers comprehensive coverage inclusive fire, burglary, consequential loss, fidelity guarantee etc.

PUNB will provide quotation for both RTT and Business Premise Takaful offered by PUNB's own panel of Takaful operators.

- 1** PDP1 and PDP2 forms (To check on the credit record of the applicant and partners).
- 2** Latest photocopy of applicant and partners Identity Card/equivalent document.
- 3** Latest passport size photo of applicant and partners.
- 4** Latest SSM search/ Certification of Registration/ Business License.
- 5** Latest Management Account – at least until two (2) months prior to application (if applicable).
- 6** Latest 3 months' bank statement (if applicable).
- 7** Business details*
- 8** Copy of Invoice/Quotation/Receipt according to project cost. These documents are used for evaluation and disbursement.
- 9** Support letter/contract award from mentor/contract awarder/special project owner and any other relevant documents requested by PUNB.
